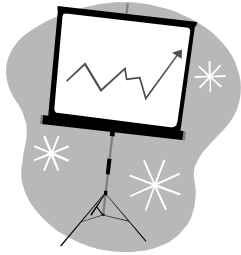


## THE ONE STEP FURTHER PROGRAM

IELLA's program consists of three steps:

**STEP 1:** A presentation informing you of your rights and options as a teen parent.



**STEP 2:** Consult with a lawyer to obtain confidential counsel & advice.

**NOTE:** You will be interviewed to determine eligibility and you must have parent/guardian permission



**STEP 3:** Legal documents can also be prepared for you if recommended by the attorney you meet with.



## THE ONE STEP FURTHER PROGRAM ADDRESSES THE FOLLOWING LEGAL ISSUES:

TEMPORARY RESTRAINING ORDERS  
(DOMESTIC VIOLENCE & CIVIL HARASSMENT)  
PATERNITY  
CHILD CUSTODY  
CHILD SUPPORT  
MODIFICATION OF EXISTING COURT ORDERS

ATTORNEY COURTROOM REPRESENTATION CAN BE PROVIDED AT NO CHARGE AT THE DISCRETION OF IELLA'S EXECUTIVE DIRECTOR AND/OR ATTORNEY AVAILABILITY

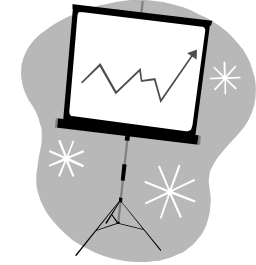

## EL PROGRAMA DE "ONE STEP FURTHER"

El programa consiste de tres pasos:

**PRIMER PASO:** Una presentación para informarle de sus derechos y opciones.



**SEGUNDO PASO:** Consulta con un abogado para obtener asesoramiento confidencial.

**NOTE:** Sera entrevistado para determinar su elegibilidad y necesita tener permiso de sus padres o guardián



**TERCER PASO:** Documentos legales se puede preparar si lo recomienda el abogado con quien habla.



## OUR MISSION NUESTRA MISIÓN

One Step Further's mission is to provide free legal services to teenaged parents who, due to lack of financial resources, have no access to the services of an attorney. These individuals might not have access to a system of justice traditionally available to the more affluent members of society.

IELLA **never** charges for an attorney consultation, or for the preparation of any legal documents recommended by the Volunteer Attorney.

IELLA **nunca** cobra por consultaciones con abogados voluntarios, o por la preparación de los documentos legales.

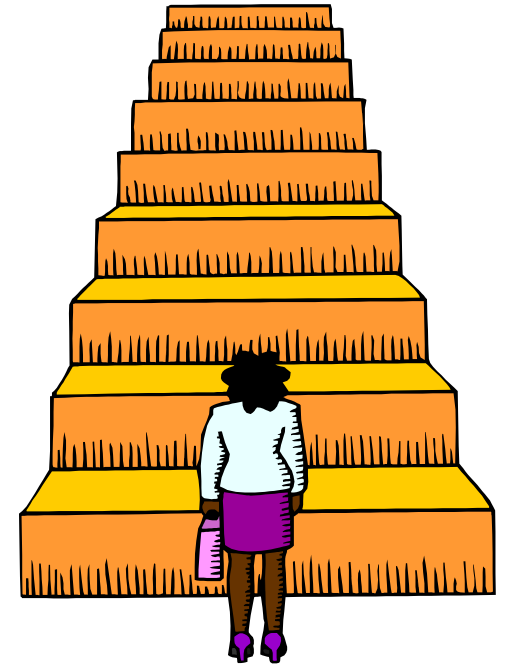
